### **Free consultation**

## Individual directions with (optional) workshop and pre-checks (strategy definition)

We recommend an optional workshop to review your business objectives and discuss the current system landscape with your IT.

This is followed by a technical analysis. Together, we will take a close look at your system using pre-checks and check whether it is ready for conversion and meets the necessary requirements. For the analysis we use, for example, the Business Scenario Recommendation Report, the Transformation Navigator, the SAP Readiness Check and the ABAP code checks with the ATC (ABAP Test Cockpit). #### **Process analyses**

In order to be able to estimate the effort of the entire project, process analyses are carried out during the third step. The short analysis and the detailed analysis provide an initial picture of the scope and effort of the project.

Experience shows that the short analysis is often used for a conversion (brownfield) and the detailed analysis for a new implementation (greenfield). Among other things, the detailed analysis provides more detailed information on process optimisations and allows for a higher accuracy in cost estimation.

At the end of the process analyses, the scope, effort and project plan are thus visible and fixed



### Preliminary projects

Here we usually carry out the following preliminary projects in the current system:

- Business partner and customer / supplier integration (CVI)
- ABAP-code-revision and depending on the desired target scenario also
- New general ledger

Then the last step is forced.



### **Transition to SAP S/4HANA**
